NDJMS Editorial Policies

1. Privacy Policy

2. Editorial Policy

Our editorial policy ensures that content published in the NDJMS adheres to high academic standards, scientific accuracy, and relevance. Articles undergo rigorous peer review by qualified experts to ensure their validity and contribution to the field. The editorial board reserves the right to accept, reject, or request modifications to submissions based on academic and ethical considerations.

3. Peer Review Policy

All submitted manuscripts are subject to a double-blind peer review process,

where both the identities of the authors and reviewers are kept confidential. Reviewers are selected based on their expertise in the subject matter of the manuscript. Authors may be asked to revise their manuscripts based on reviewers' feedback, and the editorial board makes the final decision regarding publication.
